At two years post-graduation, most of our alumni, 88.8% (16/18) are working in some type of academic setting as Assistant Professors, Post-Doctoral Fellows, or Psychologists in Academic Medical Centers. All of them have published, with an average of 12 publications and all of them have presented in professional settings, with an average of 22 presentations. Not all program graduates seek licensure, but of the 77.7% who did, 100% passed the Examination for Professional Practice in Psychology on the first try and obtained licensure.
